## SUMMARY

Proper reflection of citizen perceptions, attitudes, and opinions remains essential in recognizing the population's awareness of social issues. Moreover, this turns out to be necessary for an economy like Kosovo, where unemployment remains high while the number of social schemes continues to increase. In addition, citizens' contributions and awareness of these issues are also challenging. This further complicates social dialogue as a process that balances the interests of the parties involved, specifically employees and employers.

To ensure a comprehensive social dialogue with justice and equality for all, it is essential to present the perspective of all actors, thus enriching the ongoing social dialogue with direct data from the field. Therefore, the contribution of this research remains precisely to highlight the level of awareness of citizens based on empirical data, more specifically to track the access to income, the standard of living, the welfare state, and citizens' perceptions in these areas.

As a result, genuine social schemes and workforce activation remain the center of IKS activity, reflected in work and results achieved throughout the history of our organization. In this context, this research aims to continue a long work of IKS towards presenting and analyzing the situation in Kosovo with quantitative data. The inputs collected in this research directly serve the process or the quality of effective social dialogue, thus affecting a decent life for the citizens of Kosovo.

Inclusion remains the peculiarity of this report. In terms of gender participation, this report brings innovation to the research site itself as it includes both parts of Mitrovica, the Southern and the Northern parts. Apart from being one of the first surveys to include the citizens of North Mitrovica, the exclusiveness remains in the answers and differences between the participants on social issues. Respondents are 350 citizens, of which 250 are from the municipality of South Mitrovica and 100 from the municipality of North Mitrovica. The findings of this report tend to inform the public about the change in behaviors
(perceptions and attitudes) about the socio-economic problems of citizens from South Mitrovica and North Mitrovica. Furthermore, the findings can be summarized as:

There are differences in the family structure between both parts, where South Mitrovica leads with larger families starting from 5 members. In comparison, North Mitrovica has smaller families, with a maximum of 4 members in its composition.

In South Mitrovica, the private sector remains the primary employment sector with 34\%, while in the municipality of North Mitrovica, the public sector constitutes the leading employment sector with 43\%, and unlike the other part, the private sector accounts for only $10 \%$ of employment.

Unemployment remains high in both parts, with $14 \%$ of citizens from South Mitrovica and 17\% from North Mitrovica having no employed family members.

Respondents from North Mitrovica would work for a higher minimum wage compared to those from South Mitrovica, where $9.3 \%$ of respondents from South Mitrovica are willing to work for a salary of 151-200 Euros. In comparison, 12\% of respondents from North Mitrovica admit that 400 up to 500 Euros should be the minimum wage level.

Women of South Mitrovica are the less stable group of employees compared to women of North Mitrovica and men of both parts. While $\mathbf{1 6 . 6 \%}$ of men view it as impossible to lose their job in the next 12 months, only $4 \%$ of women thought the same- $\mathbf{1 8 . 2 \%}$ of women expected to lose their job in the next 12 months.

As a result, in North Mitrovica, the employment stability for the following year is relatively high for both men and women. $27 \%$ of men and $21 \%$ of women believe they will not lose their job in the next 12 months.

57\% of respondents from South Mitrovica consider that 201-300 Euros are enough to meet their needs, while $\mathbf{3 0 \%}$ and $\mathbf{2 5 \%}$ of respondents from the Northern Mitrovica consider that 301-400 Euros and 401-500 Euros as a decent pension for meeting needs.

About $49 \%$ of respondents from South Mitrovica think that Kosovo will be able to increase pensions, which only $9 \%$ of respondents from North Mitrovica believe.

The duration of 1 year of maternity leave is considered sufficient for the citizens of South Mitrovica, while for those of North Mitrovica, it is regarded as a short period.

## 1. SAMPLE CHARACTERISTICS AND METHODOLOGY

This research was focused on South and North Mitrovica and had a diverse age structure of respondents, ranging from 18 to $65^{+}$years old. The research was conducted through a questionnaire in which 350 citizens participated, of whom 250 were from the municipality of South Mitrovica and 100 from the municipality of North Mitrovica.

In North Mitrovica, there is a clear dominance of the middle age, while in South Mitrovica, the age structure is relatively younger. As shown in Figure 1, the youngest ages, from 18to 25, dominate women in South Mitrovica, while in North Mitrovica, the respondent women are primarily from 26-35 years old.

From the demographic structure included in this research, there seems to be a significant gender imbalance in the age of 46-55 years in the northern municipality, while in the southern one, there is no significant imbalance.
Regarding the age of the respondents: in South Mitrovica, the ages of 26 to 45 dominate, while in the northern Mitrovica, the ages over 35 to 55 dominate.



Figure 1 - Age by municipality and gender

Gender representation is tailored to what is known as the disposable sample. The gender structure has brought an almost equal representation in both municipalities. Even the representation of women in research is practically identical in the two municipalities. Out of 250 respondents in South Mitrovica, $62 \%$ are men, and $38 \%$ are women. Also, in North Mitrovica, $61 \%$ are men, and $39 \%$ are women. So there is a significant difference between the willingness of men and women to engage in research.

In North Mitrovica, there are a more significant number of people whose partners have died. This category makes up $10 \%$. Moreover, this municipality has a more significant trend of divorces, which includes $5 \%$ of the total.

In the family context, there are two different trends concerning the municipalities. In South Mitrovica, the extended family type with five or more members dominates, while in North Mitrovica, a tendency towards the extended family from the comprehensive model, where the structure with up to 4 members dominates mainly.
The average number of family members in the southern municipality is 5.31 members per family, while in the northern one, it is 3.84 members. $19 \%$ of respondents live in families
with five members each. It should be noted that the maximum number of members mentioned by respondents from North Mitrovica is eight members, while the municipality of South Mitrovica has families of 10,12 , and 13 members. These do not exceed $2 \%$ of the total sample share.



Figure 4 - Family members number by gender

North Mitrovica dominates in the categories with 1-3 employed family members, while South Mitrovica dominates in the 4-6 employed family members. However, it should be borne in mind that initially, this was influenced by a more significant number of samples. Secondly, well-being has to do with the size of the family. As noted in Figure 4. In South Mitrovica, the extended family model dominates, where the difference is close to 2 members more than families living in the North.

There is a significant difference between the two municipalities in the respondents' education levels. The highest level of non-completion of primary education is significantly higher in North Mitrovica, where $7 \%$ of respondents have not completed primary education. In comparison, this percentage is $2.4 \%$ in the municipality of South Mitrovica.

Non-education as a phenomenon is more common among women than men. In South Mitrovica, the vast majority, 43\%, have completed at least high school, while 66\% in North Mitrovica have only primary education. In general, from the surveyed respondents, men have a higher level of education than women.

Economically, both municipalities do not seem to have a favorable situation. Moreover, the level of unemployment in both municipalities is quite worrying. Such a conclusion comes from the research results, where out of 250 respondents, $14 \%$ of them in South Mitrovica stated that they do not have any employed family members. Even more worrying is the situation in North Mitrovica. There from the research results, it turns out that $17 \%$ of respondents do not have a single employed person in the household. If we look at it in general, the level of welfare is not much different in the two municipalities. North Mitrovica is slightly better off, although the number of members employed in the South is higher.

In general, it can be concluded that both municipalities do not have a high level of development, which is also reflected in a low level of welfare. Families with a monthly income of 401-500 Euros in both municipalities represent the most common category. In South Mitrovica, 16\% live on this threshold, while in northern Mitrovica, 19\%. The main concentration of families is from the category 201 to 500 Euros monthly income.

Women from North Mitrovica have declared a higher income level, which is related to better well-being than women from South Mitrovica. 13\% of women in the North live in families with incomes from 401 to 600 Euros, while 10.6\% of women in South Mitrovica live on this threshold.

## 2. EMPLOYMENT AND INCOME




Figure 8 - If you are employed, where do you work?
A significant difference between the two municipalities is seen in the employment sector, where there is a vast difference between the sectors that provide jobs. In South Mitrovica, the primary sector is the private sector with $34 \%$. In comparison, in the municipality of North Mitrovica, the public sector constitutes the primary employment sector with $43 \%$, and in contrast to the rest, the private sector constitutes only 10\%. This employment trend applies regardless of gender.

When asked what minimum wage they would work for, respondents from both municipalities were reluctant to answer. From the comparison between the two
municipalities, it is clear that the respondents from North Mitrovica would work for higher salaries than those from South Mitrovica.

The vast majority of respondents, $9.3 \%$, of respondents from South Mitrovica are willing to work for a salary of 151-200 Euros. While most of those who responded from North Mitrovica, $12 \%$ are willing to work for a compensation of 400 to 500 Euros.
At the gender level, women are willing to work for lower wages. This tendency is widely dominated in South Mitrovica. The same does not apply in North Mitrovica, where women dominate the main category of 400 to 500 Euros. So, women from North Mitrovica want to work for higher wages than women in South Mitrovica.

According to respondents from North Mitrovica, lack of connections is a crucial cause of unemployment. $12 \%$ of them believe that this is the cause of employment. This may be related to the fact that the public sector in this municipality is the leading employment generator. The second reason is that they have not found a job in their profession, as $9 \%$ of citizens think so.

For this reason, it may be due to the underdevelopment of the municipality and the lack of capacity to create jobs. A similar situation is in South Mitrovica. Citizens consider the lack of connections with people in positions as one of the leading causes of unemployment (7.3\%).

However, with almost the same percentage (7\%), respondents say they are unaware of the causes of unemployment (7\% of them). So, according to them, the lack of connections
is one of the main reasons, but also the inability to give a specific reason why they have not found a job. A large percentage is unaware of why it is not within the labor market. However, a percentage almost the same as the previous one (6.9\%) believe that they do not meet the market's requirements; this figure does not correspond to the level of education they possess.

Training also achieves one of the primary forms of gaining the skills needed for the market. Respondents were asked if they had attended training in vocational training centers. In both municipalities, the percentage of those who have been trained is very low, but the citizens from South Mitrovica have a higher interest in these training. Men have a higher interest than women, while in North Mitrovica, the interest is the same. In South Mitrovica, $6.1 \%$ of men claim to have attended QAP training, while $4.5 \%$ of women claim the same. This percentage in North Mitrovica does not exceed 1\% in both genders.

Taking into account the above-mentioned social factors on well-being, we have seen that in some aspects, North Mitrovica is better off, given the size of the family and the income. This is also noticed in the number of cases that require social assistance. In South Mitrovica, $10.6 \%$ of people receive Social Assistance, as opposed to North Mitrovica, where they receive $3 \%$. An indicator here could be the benefit of Serbia's state schemes. Households, where men are heads of the households, are the biggest beneficiaries in both municipalities, as opposed to households where women are heads, unlike North Mitrovica, where women receive more social assistance.

The way of employment is also one of the most critical issues addressed. A general opinion has been formed in both municipalities that connections are a crucial criterion for work.

The citizens of North Mitrovica think that to be employed, and you must have knowledge and competence to be used in the public sector (48\% have such an opinion).

While in South Mitrovica, connections are considered the main element for employment ( $42.3 \%$ think so). Although, many citizens have the same opinion in North Mitrovica. $32 \%$ of them have the same opinion as the respondents from the northern part that connections are the only criterion of employment.

A significant percentage, $24.5 \%$, in South Mitrovica, also think that being competent is the criterion for employment. In North Mitrovica, there is a higher percentage of those who believe that bribes should be paid $7 \%$, compared to South Mitrovica with $5.6 \%$. Men are generally more pessimistic about employment than women.

Above, we saw that the private sector is the second sector in North Mitrovica and the first sector to generate jobs in South Mitrovica. Therefore, there are two essential differences in the perceptions of citizens. About 44\% of respondents from North Mitrovica think that employment in the private sector is done through people who know us and help us in the process. Against the respondents from South Mitrovica, who are more optimistic about this sector, where $35.2 \%$ think that the skills and competencies are enough to be employed in this sector.

The situation in South and North Mitrovica changes regarding future employment. Women in South Mitrovica tend to look for work in Europe more than men ( $16.6 \%$ ), but the opposite is happening in North Mitrovica.
Whereas women in North Mitrovica prefer to find a job in Kosovo ( $17 \%$ of them). The opposite happens to be for men in both municipalities. Men in South Mitrovica have a higher tendency to seek a job in Kosovo than men in North Mitrovica who have a higher migration tendency. $25 \%$ want to find a job in Europe versus $12 \%$ of women.
The opposite of South Mitrovica is the determination for the future, as women are more insecure about their future.

## 3. BELIEFS AND ATTITUDES

Stability in the current job is also a critical issue, for which the respondents from both municipalities were asked. Regarding the possibility of being unemployed in the next 12 months, a large percentage of men from South Mitrovica (16.6\%) said that it is not possible at all. This shows a high level of stability at work in a significant percentage of male respondents. Unlike men, women in the same municipality do not have the same stability. $18.2 \%$ indicated that the possibility of being unemployed in the next year is somewhat probable, and $5.3 \%$ very likely. Only $4 \%$ said it was not likely to lose their job in the following year. So, the difference between men and women who said that it is not at all possible to lose their job is $12.6 \%$, which shows in the best way the security of stability in the workplace.
Meanwhile, unlike South Mitrovica, in North Mitrovica, the situation seems to be different. Employment sustainability for the following year is relatively high for both men and women. $27 \%$ of men and $21 \%$ of women believe they will not lose their job in the next 12 months. At the same time, the possibility of losing the job is believed by $13 \%$ of men respondents and $12 \%$ of women respondents.

Because Kosovo does not provide health insurance for employees, personal and family medical care weighs directly on the family budget and can often be neglected. About $26 \%$ and $17 \%$ of men participants in the survey from the municipalities of South and North

Mitrovica, respectively, indicate that they may not receive medical care in the next 12 months.

While $18 \%$ of women respondents from North Mitrovica say that it is not at all possible for them not to receive medical care and only $2.4 \%$ from South Mitrovica have the same attitude, this shows a discrepancy in attitudes towards women in both municipalities. Those in North Mitrovica say that it is not possible not to receive medical care, which aims to be the opposite of that in South Mitrovica.

How the citizens of Mitrovica view the cost of pensions in Kosovo is another issue that was addressed in the survey. About $49 \%$ of respondents from South Mitrovica think that Kosovo will be able to increase pensions, which only $9 \%$ of respondents from North Mitrovica believe. $40 \%$ said that the current status of pensions is affordable for the Kosovo budget.

Another critical issue addressed in this research is citizens' perception of the insufficiency of income to cover basic needs.

A large percentage of citizens from South Mitrovica (26.3\%) estimate that for every 100 people, more than 50 people do not have enough income to cover basic needs. Contrary to what citizens in South Mitrovica believe, a significant percentage of citizens in North Mitrovica (23\%) believe that only 5-9 people in 100 people do not have enough income to cover basic needs.

The women from both regions show a more positive perspective on this issue.

Maternity leave has particular importance and is one of the topics that require special attention, so it is addressed in this research.

However, regarding maternity leave, a discrepancy in attitudes is observed in the Southern and Northern municipalities. In South Mitrovica, 68\% of respondents consider the length of maternity leaves appropriate. It is worth noting that $26 \%$ of the responses come from women respondents. But, such an opinion is not the same in North Mitrovica. There, $41 \%$ of respondents consider this break short, and a slight difference is observed between the perceptions of women and men respondents.

## 4. PERCEPTIONS ABOUT THE STATE AND WELFARE

This research also addressed the perceptions of health services in public institutions provided by Kosovo institutions during the last 12 months and received by the citizens of South and North Mitrovica.

A significant imbalance is observed in the receipt of health services by men in South and North Mitrovica.
$45.7 \%$ of male respondents from South Mitrovica stated that they had received health services, while $42 \%$ of male respondents from North Mitrovica denied that they had received health services.

In general, fewer women respondents have received health services in the last 12 months, $27.1 \%$ and $14 \%$, respectively, for South and North Mitrovica.

How satisfied are they with the efficiency of the public health services received? From the respondents, we see that $42 \%$ of men consider the services received somewhat and moderately efficient, while women have lower levels.

Given the socio-economic problems of citizens in Kosovo, respondents were asked about the sufficient amount of the monthly pension, which is enough to meet basic needs. $57 \%$ of respondents from South Mitrovica consider that 201-300 Euros are enough to meet their needs, while $30 \%$ and $25 \%$ of respondents from Northern Municipality consider the category 301-400 Euros and 401-500 Euros as a pension worthy of meeting the needs.

Many benefits and public services are paid for through the money collected from taxes. When asked if the government would run before the election to raise taxes and provide more public services, $48.6 \%$ of respondents from South Mitrovica supported this statement, as opposed to North Mitrovica, which was supported by only $31 \%$. Respondents. Meanwhile, in the statement that if the government would be put before the election to reduce taxes but provide more minor public services, $26.3 \%$ of respondents from South Mitrovica and 17\% from North Mitrovica supported it. It is worth noting that almost half of the respondents from North Mitrovica did not endorse any of the allegations.

## 5. CONCLUSIONS AND RECOMMENDATIONS

The subject of this report, in the first place, highlights the differences, which in some cases are big ones, and characterizes the two municipalities of Mitrovica as only two of the 38 total municipalities of Kosovo. Despite the physical closeness, the surveyed citizens show different views, perceptions, and attitudes compared to their neighbors from the other municipality.

In the context of social policies, the Mitrovica region is a unique case study. Over the past two decades, the entire economy of the area that once was associated with the metallurgy industry and its services has been transformed on both sides of the lber river to obtain utterly different development from each other, producing this way different social realities. A similar story is also in other parts of the country, especially along the borders of Albanian-majority and Serb-majority municipalities.

As the primary aim of social policies and other protective measures is for the most vulnerable groups in society, other specifics in all regions of the country should also be taken into account to have inclusive policies and address the needs and priorities of the citizens who intend to help.

Another goal of social policies is also to increase social cohesion and reduce social inequalities, so they (social policies) should serve to be put in the function of the integration of some citizens of Kosovo of Serbian ethnicity, who still refuse to accept Kosovo as their state. Vulnerable groups, especially in Serb-majority communities, are even more susceptible than the same groups living in Albanian-majority areas, as they also weigh in isolation within the country.
In the local context, based on the Law on Local Self-Government, municipalities have the competence to advance social policies for their citizens beyond the minimum that is guaranteed by law for all citizens of the country. They also have higher competencies in local economic development and areas related to employment and welfare. Municipalities should proactively identify precise needs through accurate measurements and try to address them through their policies and development programs.

Currently, the two municipalities do not synchronize any aspects of operation and planning and operate entirely separately. Thus, a lot of work is duplicated, each municipality is non-harmonized and interconnected with the rest of the city, and the priorities and expectations of citizens differ on both sides of the river. The current study
highlights the diversity within small communities across the country. It is a reminder to decision-makers and policymakers that their decisions must be informed of the needs of citizens, both from the majority and minority communities, as only in this way will they serve the purposes for which they were created.
